## **Update from the National Ageing Research Leads**

The National Ageing Research Leads meet regularly, and I thought it would be useful to share some of the group's recent activity. We are working on developing a best practice paper around supporting older people in research. This is still at an early stage, but under the leadership of Prof Miles Whitham, the project should complete in 2022. The challenges of ageing research in the midst of the ongoing pandemic are being felt across the UK, but important multi-centre trials in older adults continue to recruit well, for example CONFORM-OH (drug treatment in orthostatic hypotension) and CHIEF-PD (cholinesterase inhibitors in Parkinson's). If you would like to hear more about these trials and potentially bring them to your site, then let me know.

#### **NIHR Survey**

An ongoing problem in clinical research is that we have enthusiastic people who want to help with projects but who don't know how to get started, and we have multi-centre trials that are looking for new sites but don't have the necessary contacts.



The National Institute for Health Research (NIHR) is collating a database of researchers who could act as a local principal investigator (PI) for studies in older adults. If you would be interested in helping with research, then please add your name to the database. Although it is not a competition, every few months the NIHR look at how many names are on the database, and with a few more names Scotland could be the top site! Former NRS Ageing lead, Professor Gillian Mead, was awarded the Tenovus Scotland, Lady Illingworth Trust Award. This is a 5-yearly award for an outstanding contribution to the disabilities which affect older adults. With her portfolio of research around stroke, exercise and end of life care, Prof Mead is a most deserving winner of the award.
